We ask that if you make it on the team, the crew club will be your priority on Fridays during the season and you will not make other commitments that will interfere with attendance.

When: The program will run on Fridays from 4:00-6:00pm at the ARC boathouse in Hooksett, NH. Parents will be responsible for carpooling their children to and from the boathouse each Friday. The first practice will be on Friday, September 6th and will run every Friday until October 25th, when there will be a fun race with the high school team.

Cost: There is a participation fee of \$175 to cover the cost of insurance, coach fees, gasoline for the launches, and a team t-shirt.

Team Meeting: All rowers and their parents will be expected to attend a meeting on Tuesday, September 3th in the Lurgio Media Center at 7pm.

Priority is given to 8th grade students and then 7th graders will be accepted on a first come, first serve basis.

- Take exit 11 ramp off I-93 (Pay Toll)
- · Turn left (North) onto Hackett Hill Rd.
- Turn left (North) onto RTE-3A (W. River Rd.)
- · Turn right (East) at traffic light onto Main St.
- Proceed 0.4 miles turn left (North) onto Merrimack St.
- · Proceed approximately 1 mile to Hooksett District Court
- Turn left into Hooksett District Court driveway
- Proceed 0.2 miles to boat house

2019 CODE OF CONDUCT AND MEDIA RELEASE

It is the mission of the Bedford Crew Club to provide Lurgio Middle School students with the most enriching team-oriented athletic experience possible, while setting the highest standards of academics, responsibility, and sportsmanship for its participants. This Code of Conduct is being implemented for this purpose.

- 1. The student/athlete must be in good academic standing at Bedford High School. If not, the student will be required to work with the coach on a remediation plan to balance academics with participation on the crew team.
- 2. Team members are expected to be present at all practices, team meetings, contests, and special occasions unless excused by the coach. Unexcused absences may result in loss of rowing privileges and potential ineligibility.
- 3. The possession or use of tobacco, alcoholic beverages, or illegal drugs is prohibited by members of Bedford Crew. In addition, members are not allowed to be in the vicinity of the occurrence of such activities. Any misconduct resulting in a school suspension will also not be tolerated.
 - a. Upon evidence of possession or use of any of the above, and including egregious misconduct as outlined in the BHS handbook under "Citizenship and Student Behavior" resulting in a school suspension, the student/athlete will be suspended from the team, pending investigation.
 - b. The final decision to remove a student/athlete from athletic participation for the completion of the season will be made by the Coach in consultation with Bedford Crew Board of Directors.
- 4. Team initiations and hazing are strictly prohibited. Any athlete participating in such behavior, or who has awareness of such behavior without reporting it will be subject to permanent removal from the team.
- 5. In accordance with the above, I give Bedford High School permission to release the academic status and/or disciplinary actions against the student to a board representative of Bedford Crew.
